
Al joined Georgetown in 2018 and brought an infectious enthusiasm for ideas, books, and publishing to Georgetown. He established the first Faculty Editorial Board and reached out to many people across the university to share his excitement about the Press. Through his vision and leadership, Al diversified the publishing portfolio to expand the scope and kind books that the Press publishes, adding the area of Global Business and books in all fields that reach beyond academics and connect us more deeply to the university, the broader DC community, and readers around the world. He took great pride in mentoring a new generation of publishing professionals too shared through the Press's expanded internship program for Georgetown students, a course he taught at Georgetown University called The Art of Publishing, and also as an adjunct faculty member in George Washington University's Publishing Mastering Program.

Prior to becoming Director of the Georgetown University Press, he served as editor-in-chief and associate director of Princeton University Press and UK editorial director for Social Science and Humanities books at Blackwell Publishing and John Wiley & Sons.

Al was devoted to his family, who have our deepest condolences, and leaves behind a daughter Eve, a son Jaime, and his wife Claire.

He is deeply missed and remembered for the strong legacy he leaves for the Press as well as his kindness, good humor, and love of books.

THE FIRST HISTORY OF THE FANZINES THAT EMERGED FROM WASHINGTON, DC'S HIGHLY INFLUENTIAL PUNK COMMUNITY

DIY culture has always been at the heart of DC's thriving punk community. As Washington, DC's punk scene emerged in the mid-1970s, so did the periodicals—"fanzines"—that celebrated it. Before the rise of the internet, fanzines were a potent way for fans to communicate and to revel in the joy of fandom. These zines were more than just publications; they were a distillation of punk's allure, connecting the city to the broader punk community. Fanzines remain a meaningful, tactile, creative medium for punk fans to connect with like-minded people outside the corporate-controlled world.

In *Keep Your Ear to the Ground*, the archivist and musician John R. Davis unveils the development of punk fanzines and their role in supporting DC's hardcore and punk scene from the 1970s into the twenty-first century. He sheds new light on DC's scene and highlights some of its key personalities, including many who are often left out of punk history, with high-quality images of rare zines and insights from numerous interviews with zine creators and musicians. This book vividly weaves together the origin of zines and their importance in underground communities.

For punk enthusiasts, zine creators, American studies scholars, and anyone who has ever felt like an outsider, *Keep Your Ear to the Ground* traces how the unique environment of Washington, DC, helped zines thrive.

JOHN R. DAVIS, former drummer of Q and Not U, is the curator of special collections in the University of Maryland's Michelle Smith Performing Arts Library. He co-curated the Visualizing Fugazi exhibit at the Lost Origins Gallery. His articles and commentary appear in the Washington Post, NPR, Notes, The Journal of Popular Culture, Punk, and Post-Punk.

QUESTION AND ANSWER WITH THE AUTHOR

You mentioned your personal history with fanzines—what inspired you to write a book about punk fanzines in Washington, DC, and how did your experiences shape the way you approached this book?

Not long after I got into punk as a teenager in the early 1990s, I started publishing my own fanzines about the DC punk scene. I'd been inspired by some kids a few years ahead of me at my high school, as I was amazed by the zines they wrote, designed, and published themselves.




I decided to take an indefinite break from being a touring musician in the early 2010s and went to graduate school for a Master's in Library and Information Science. Not long after I started working at the University of Maryland's Special Collections in Performing Arts (SCPA) and became curator there in 2020. This led to various scholarly articles, a book chapter, and conference presentations about the DC punk scene and the archives at UMD.

After presenting at the DC History Conference in 2017, I met Hope LeGro of Georgetown University Press. She asked if I'd ever considered writing a book on the history of DC punk fanzines and, indeed, I had wanted to do something like that for a few years.

What do you hope readers will glean about the history of punk fanzines from this book?

Just like punk rock showed that anyone can play music, no matter how skilled you are at singing or playing an instrument, punk fanzines demonstrated that anyone could and should make a zine to share their punk fandom. The main thing I want readers to understand is that punk rock communities are about more than the bands. Without all of the other aspects of the community, you lose the energy that binds everything together.

CRAIG ALAN MILLER, MD, is a board-certified cardiovascular surgeon and author of three books on medicine and medical history, *The Making of a Surgeon in the Twentieth Century; The Big Z: The Life of Robert M. Zollinger*; and A Time for All Things: The Life of Michael E. DeBakey.

CHARLENE DREW JARVIS is a neuroscientist, politician, and educational leader. She was elected six times to the Council of the District of Columbia (1979–2000) and served as president of Southeastern University.

QUESTION AND ANSWER WITH THE AUTHORS

What inspired you to choose Dr. Charles R. Drew as the subject of a biography?

As a physician I was aware of Drew's name but only vaguely cognizant of his accomplishments. I knew he had accomplished something in the early days of blood banking. One would naturally wonder how he came to do so during the first half of the 20th century as an African American, faced with the obstacles of the era (and beyond). Friends and colleagues in the medical and history communities suggested I consider writing about Drew, and when I realized that no adult




biography had been written about him, I became very intrigued. When I reached out to his daughter, we developed an immediate connection and the project was instantly off and running.

During your research, did you come across anything that surprised you or challenged your previously held beliefs about the subject? Did you make any surprising discoveries?

Certainly, I discovered many things about Charles Drew that had either been unreported in the past or were recorded inaccurately. Such errors tend to propagate and become conventional wisdom surprisingly easily. A few will be put to bed by this book. There are also new insights that will surprise some people.

How did you approach the task of making your work accessible to readers who may not hold a scientific background?

I always write keeping in mind the perspective of the scientific layman. Hopefully, if I've done a reasonable job of that, one can appreciate the accomplishments of Drew and other scientists in a qualitative way, even if the details of their achievements are more completely understood by those who actually work in the field. They say only a composer can really appreciate Mozart, but his stuff sound pretty good to the rest of us, too!

A HISTORY OF BLACK POETS IN WASHINGTON, DC, REVEALS HOW THEY HAVE REFLECTED AND TRANSFORMED AMERICAN CULTURAL DISCOURSE

Washington, DC, has long been home to a dynamic and vibrant African American literary community, despite often being overshadowed by the literary worlds of New York and Chicago. In No More Worlds to Conquer, the local poet Brian Gilmore uncovers the buried legacy of Black poets in Washington. He traces the literary life and politics of Black poets in the nation's capital since Paul Lawrence Dunbar, showing how well-known American poets such as Sterling Brown and Jean Toomer were mentored in DC by poets like May Miller and Georgia Douglas Johnson and making the case for the city as a center of American literature.

Gilmore draws on meticulous research, personal interviews, and his own deep knowledge of the local literary community to connect generations of writers and document a poetic community that transcends Washington. He reveals the intricate intersections, networks, and influences that have shaped the city's poets and how they have influenced American poetry for a century.


More than a historical account, *No More Worlds* to Conquer is a personal exploration that bridges the past and the present. Gilmore, who was born and raised in DC, illuminates this history and reflects on his own place in its literary tradition. This multigenerational account will resonate with poetry enthusiasts, local DC scholars, and anyone interested in the rich traditions of African American literature.

BRIAN G. GILMORE is the author of four books of poetry—elvis presley is alive and well and living harlem; Jungle Nights and Soda Fountain Rags: Poem for Duke Ellington; We Didn't Know Any Gangsters, an NAACP Image Award nominee and a Hurston-Wright Legacy Award nominee; and come see about me marvin, a Michigan Notable Book Award recipient. He is a public interest lawyer and a senior lecturer at the University of Maryland – College Park.

QUESTION AND ANSWER WITH THE AUTHOR

How did you tackle the difficult research task of documenting the history of Black poets in Washington, DC, given the challenges associated with fragmented historical records?


Fortunately, there is a lot of documentation. Howard University and the city's many print newspapers provide an easy source to get started. Then, there are just books, and journals, and all sorts of sources to pull from. George Washington University has done a great job of keeping the records and papers of writers. Many of the writers who lived and wrote here left behind good



records. Many writers are still around. I could have written probably a lot more than I did.

In what ways did your own experience as a poet and writer shape the way you approached the research and collected your findings?

I came along right at the time that one major era was winding up and another was beginning. I knew that there are two major periods for most Black writers in America: the renaissance period (I don't use "Harlem Renaissance" normally) and the Black Arts period. While many of my contemporaries were Black Arts-influenced poets who took those lessons and influences seriously in their work as they wrote about apartheid, the Reagan era, and the backlash against racial progress in the 80s and 90s, the spoken word / hip-hop period was also part of this as well. I felt I was uniquely situated to discuss all those new tracks for Black poetry in the city because I was part of it. I was a poet who wrote poetry mostly for the page, but the spoken word poets energized Black poetry. All of us were part of creating poetry for the page and the stage. It was a significant part of Black poetry always, but in the 1990s it truly became a phenomenon within itself because of music—hip-hop and, locally in the city, go-go music.

QUESTION AND ANSWER WITH THE AUTHOR

What do you hope readers glean from this book, and how do you hope readers can apply these skills in their own lives?


The objective of the book is to ensure that readers learn that the corporate chess game is always in play, whether it is an internship or a first job at a corporate firm. It does not matter which industry, whether it is finance, wealth management, PR and communications, consumer and retail, corporate marketing, law, medicine, or real estate. It also does not matter whether you perceive the chess game or not. It's in play either way, so you may as well learn how it is affecting your progress.



What do you think of when you hear the term "corporate chess game"? What is the definition of the term?

The corporate chess game is what we call the strategies that successful players use to their advantage when confronted with business scenarios that may derail their success. To be used effectively, the strategies need to be appropriate to the circumstance, and therefore the first step before engaging in the chess game is to observe and understand the unwritten rules of your organizational culture. Too often the norms of the culture are never explicitly discussed in the firm. How does one learn them? The subtleties of how the norms vary over different situations must be observed actively. Only then can someone plan their own course of how to play the chess game to their own advantage.

In most firms, each situation requires a specified set of moves based on a planned strategy. Just like in chess, rarely does a direct attempt to win the game quickly succeed. The chess player's goal is to win at the end of the game. Sometimes, this requires some indirection. Sometimes, it requires slowing down, listening, and observing carefully.



In 1831 Sister Gertrude Wightt, the directress of Georgetown Academy (now Georgetown Visitation Preparatory School), donned the hat and cape of one of her students and abruptly left the academy and life as a nun. She soon became a fixture on the Washington social scene and an intimate of Dolley Madison.

The Two Worlds of Ann Gertrude Wightt is the first comprehensive biography of the enigmatic Wightt. Drawing from a rich cache of previously overlooked primary sources, the book meticulously explores Wightt's transformation from respected academy directress to celebrated "parlor politician" in the nation's capital. It delves deeply into her innovations in female education, her unprecedented departure from convent life, and her remarkable social reinvention. The author reveals a complex narrative of the opportunities and limitations that Catholic religious life posed for this gifted, ambitious, and socially prominent young woman.



QUESTION AND ANSWER WITH THE AUTHOR

What drew you to explore Ann Gertrude Wightt's story in the historical context of so many other cases of "runaway nuns"?


I first became aware of Ann Gertrude Wightt in the early 1980s when I was conducting reconnaissance for my PhD dissertation research at the University of Maryland, College Park. Although I was familiar with alleged "escaped nuns" like Rebecca Reed and Maria Monk, I had never heard of any "runaway nun" by the name of Sister Gertrude Wightt. I filed her name away for further investigation when I finished the dissertation.



While working at the Archives of the Archdiocese of Baltimore in 1985, I discovered the original letter written by Sister Gertrude to Archbishop James Whitfield, in which she explained the reason for her abrupt departure. In the years since, I turned up more sources, but only when I found myself in need of a paper topic for a scholarly conference in 2016 did I finally get around to a serious investigation of the story of Ann Gertrude Wightt. Since that time, I have researched her life in earnest.

You mention a lack of primary sources in your research posing a significant challenge in reconstructing Ann Gertrude Wightt's life-how did you navigate these gaps in information?

One the biggest challenges for anyone attempting a biography in women's history is locating sufficient sources on their subject to complete the project. While constructing a timeline of Wightt's life, I identified some frustrating gaps in the records. The spottiness of sources for some periods means that this volume cannot be a conventional biography in the sense of chronicling every year of the subject's adult life or recording her thoughts about every important event she experienced. Despite the few sources authored by the subject, I am heartened by the belief that I have found enough primary and secondary sources to analyze in detail key parts of her life and to sketch the broad outlines of others.



QUESTION AND ANSWER WITH THE AUTHOR

What inspired you to delve into the friendship between yourself and Pope Francis?

In our first telephone contact in September 2013, I immediately felt a great understanding with Bergoglio. The very fact that, following a letter from me, it was the Holy Father who called me to testify to his sensitivity to the importance of the Terra Madre network, and more generally to the issues that have always characterized Slow Food's commitment, immediately made me realize the harmony that could be created. His ability to talk about global issues in a pragmatic way, without limiting himself to an exclusively




religious perspective, represented a point of encounter and shared reflection.

How did you balance your own differing perspectives and worldviews with those of Pope Francis while writing?

Our friendship stemmed from the many points we had in common philosophically and politically. Also our common Piedmontese origin allowed us to feel united—in our life paths, in the history and culture of our families, and not least in the Piedmontese dialect. It is also true that I always stressed to Bergoglio the extraordinary nature of a friendship born between the head of the Catholic Church and an agnostic. One of the most beautiful definitions of friendship was given by Michel da Montaigne: "because it is he, because it is I." This phrase sums up the true essence of mutual respect.

You mentioned your conversations and ensuing relationship with Pope Francis: How would you say that shaped the ways in which you approached this book?

The relationship with Pope Francis had a profound impact on how this book was approached. The Pope provided a key to reading it that is not limited to technical or economic aspects, but puts human dignity at the center. This is a new way of reading the global crisis, and this has made it possible to approach the subject with a broader perspective that goes beyond numbers and statistics. He has shown that it is possible to bring different realities together for a common goal. His ability to maintain hope, despite difficulties and resistance, was a fundamental lesson in approaching this book with a constructive and not just critical perspective.



QUESTION AND ANSWER WITH THE AUTHOR

You mention the tension between saintly compassion for animals and a rationally justified use of them: How did you balance these conflicting ideals?

This is one of the difficult questions—difficult because there is no easy formula that we can use to discern correct answers when facing this tension. I appeal to the idea of God's kingdom as already and not-yet: Jesus inaugurated the kingdom but its fullness has not yet come to help push us in the right direction. We humans are regularly tempted toward self-serving




arguments and away from ones that demand difficult moral responses, and thus one way to understand the task of the Christian to keep pushing ourselves toward the kingdom's ideals and away from self-serving biases.

Did you come across any conflicting arguments during your research that were particularly difficult to reconcile?

Related to the tension above is conflict between the anthropocentrism of the Bible and the Christian tradition (humans are unique) and the idea that God loves creation and the animals within it. Some theologians argue that since the Bible was written by humans (even though inspired by God), it reflects an innate human-centrism that should be questioned or even challenged as a human bias. Others argue that the Bible's privileged status is essential to divine revelation. I see Pope Francis's teaching as an endeavor to affirm the second (human uniqueness) while also underscoring that God's love and providential care extend to nonhuman creatures.

How do you hope readers, Christian or otherwise, respond to your book? What message do you hope they take away, or what changes do you hope they will make after reading this book?

Some people who read the book will be interested in the question of animals in heaven because they hope that they will see their beloved dogs and cats again. I understand that instinct. But I hope that book will help people see that the compassion and love that they have for companion animals is similar to the love that God has for all his creatures. And thus, our love for dogs and cats is just the first step in learning to love all God's creatures.

QUESTION AND ANSWER WITH THE AUTHOR

How do you see our current communities adapting to new roles within this "regenerative paradigm" you mention?

Communities worldwide are embracing a regenerative paradigm by shifting to holistic, life-sustaining approaches, such as Andhra Pradesh's state-wide organic farming initiative, which supports over 800,000 farmers in transitioning away from chemical agriculture. This includes rebuilding soil fertility, reclaiming local food sovereignty, and integrating traditional ecological knowledge, as seen in the




restoration of the buffalo to the Great Plains, led by Indigenous groups. Recognizing the deep interconnection between food, climate, and justice, communities are also working to restore waterways, as seen in the removal of obsolete dams on the Elwha and Klamath Rivers, which has revived fish populations and honored the Yurok Tribe's leadership in securing legal personhood for the Klamath River. Rather than simply minimizing harm, these efforts actively repair damaged relationships between land, people, and planetary health, offering hope for a more adaptable and equitable future.

What do you hope readers, especially those who may have climate anxiety, take away from this book?

Feeding the Future reassures readers that while national governments and global institutions may not be leading the food system transformation, the shift toward regeneration is already happening. People around the world are building alternative economies, regional food systems, and large-scale land restoration projects.

The key takeaway for readers is to embrace Active Hope—a concept introduced by Joanna Macy by:

- 1. Seeing the current reality clearly—acknowledging the deep structural issues in our food system, including human supremacy over nature, the obsession with yield, and the false promise of technology as a savior
- 2. Envisioning a different direction—one rooted in regenerative, reciprocal relationships with the rest of nature
- 3. Taking action within their spheres of influence—working toward systemic food systems change through localized, community-driven initiatives







In the early days of the Cold War, the United States faced a crisis in intelligence analysis. A series of intelligence failures in 1949 and 1950, including the failure to warn about the North Korean invasion of South Korea, made it clear that gut instinct and traditional practices were no longer sufficient for intelligence analysis in the nuclear age. The new director of the Central Intelligence Agency, Walter Bedell Smith, had a mandate to reform it.

Based on new archival research in declassified documents and the participants' personal papers, The Intelligence Intellectuals reveals the neglected history of how America's brightest academic minds were recruited by the CIA to revolutionize intelligence analysis during this critical period. Peter C. Grace describes how the scientifically sound analysis methods that they introduced significantly helped the United States gain an advantage in the Cold War, and these new analysts legitimized the role of the recently created CIA in the national security community. Grace demonstrates how these professors—such as William Langer from Harvard, Sherman Kent from Yale, and Max Millikan from MIT—developed systematic approaches to intelligence analysis that shaped the CIA's methodology for decades to come.

Readers interested in the history of the Cold War and in intelligence, scholars of intelligence studies, Cold War historians, and intelligence practitioners seeking to understand their craft's foundations will all value this insightful history about the place of social science in national security.

For decades after Moroccan independence in 1956, the Amazigh people struggled for their indigenous rights and cultural preservation took center stage. They fought against their erasure under an exclusivist Arab nationalist regime. Although they were successful, the history of the Amazigh Cultural Movement and its profound impact on North African society have remained largely inaccessible to English speakers, leaving a gap in our understanding of postcolonial resistance, indigenous rights, and cultural preservation efforts.

Translated into English for the first time, *The Amazigh Revival* is the memoir of Brahim Akhiate, a leader in the Amazigh movement. It offers unprecedented insight into the Amazighs' fight for recognition and a place in Moroccan society through the firsthand account of a key figure who guided it, starting in the 1960s. Akhiate describes the personal sacrifices, ideological tensions, intellectual debates, and eventual triumphs that led to the constitutional recognition of the Amazigh language and a more inclusive identity.

This memoir offers English speakers crucial access to previously unavailable perspectives on one of North Africa's most significant cultural movements. Scholars and students across multiple disciplines will benefit from Akhiate's detailed recounting of this important political and cultural moment in Moroccan history whose impact has been felt across North Africa.

BRAHIM AKHIATE (1941–2018) was a scholar, author, and Amazigh organizer who founded the Moroccan Association for Research and Cultural Exchange.
